NOTE: White cloth athletic tape may be worn to support previously injured appendages as well as to protect any uninjured areas from becoming injured. Areas allowed to be taped include: fingers, thumb, wrist and toes. This tape may be wrapped no more than two times around the appendage, and cannot be used in such a way as to prevent or severely restrict the movement thereof.
